**CATEGORY 'B' Admissions
(Into MBA & MCA courses for the year 2011-2012)**

It is hereby informed to the Managements of Private Unaided Minority & Non Minority MBA & MCA colleges that;

- *The **cutoff date** for the submission of category 'B' admissions list (30% seats of sanctioned intake) is extended to **25th November, 2011.***
- *The seats shall be filled following the rules of admissions prescribed in G.O.Ms.No.59, 66 & 67 and guidelines issued in G.O.Ms.No.61.*
- ***Eligibility criteria for admission (cat B seats):***
 - *50% marks in aggregate in the qualifying examination or CGPA equivalent to 5 on scale of 10 for NRI candidates*
 - *Rank obtained in ICET-2011 or on the basis of rank in All India Common Entrance Test and not less than 50% of Marks (45% of Marks in case of reserved categories) aggregate in the qualifying examination.*
 - ***Vacant seats or unfilled seats** in the above categories shall be filled with eligible candidates including those securing not less than 50% of marks aggregate in the qualifying examination.*

Note: Foreign Nationals are not eligible for admission.

The following information along with evidence should be furnished together with the admission lists.

- a) **Original Paper Notification** issued for Category 'B' seats (and Category 'A' & 'B' seats for Minority Colleges only).
- b) Lists of Applicants to Category 'B' seats with name, address, ICET-2011 Rank, percentage of aggregate marks in qualifying examination, Community Certificate.
- c) Copy of Qualifying examination, Intermediate & 10th class Marks Memos and copy of community certificate.
- d) The college shall prepare merit list of the eligible applicants in **Descending order of ranks & Descending order of Percentage of marks**(to those who have not secured ICET-2011 rank), admissions shall be made following the merit lists.
- e) If NRI / NRI Sponsored / Other State Candidates are not claiming admission under Category 'B', to the extent of percentage of seats mentioned in G.O.Ms.No.59, a certificate /undertaking need to be furnished to the effect that no such candidates were available for admission and that the admissions were made strictly according to G.o.Ms.No.61.
- f) **The list of candidates admitted should be provided in hard copy & soft copy (IN MS-EXCEL FORMAT ONLY) and in the prescribed proforma only (can be downloaded from www.apsche.org), without which the list will not be accepted.**
- g) Proof of information available in the college website.
- h) Minority Institutions which made admissions through SW-II/III should also submit proof pertaining to Minority status of the students.
- i) Proforma of Annexure can be downloaded from the website www.apsche.org.

The admission list as shown in the Annexure I & II shall be submitted separately for MBA & MCA programmes. It is also informed that late submission beyond the cut-off date mentioned above will not be permitted.

- The last date for submission of the admission lists (Category B seat) to the Competent Authority (APSCHE) is extended to **25th November, 2011**.

Note: No proposals submitted after the stipulated date i.e., 25.11.2011 shall be accepted under any circumstances, and the College Management will be held responsible for the ratification of the students admissions.
